EANGUS

The Enlisted Association of the National Guard of the United States (EANGUS) was formally organized in 1972 with the goal of increasing the voice of enlisted persons in the National Guard. As such, EANGUS is a non-profit organization dedicated to the principles of providing an adequate national defense and promoting the status, welfare, and professionalism of the men and women of the Army and Air National Guard by supporting legislation that provides adequate staffing, pay, benefits, entitlements, equipment, and installations for the National Guard.

Beginning with twenty-three states, EANGUS now represents all 50 states, Guam, Puerto Rico, the US Virgin Islands, and the District of Columbia, and has an association comprised of those who serve the National Guard on national tour. With a constituency base of over 450,000 Soldiers and Airmen, their families, as well as tens of thousands of retired members.

Headquartered in Washington D.C., EANGUS maintains a full-time staff to represent your interests to the Pentagon and on Capitol Hill. EANGUS co-chairs the Military Coalition Guard/Reserve Committee and has presence on TMC Health Care, Membership, MWR & Milcon, Personnel, Retirement, Survivors, and Veterans subcommittees. Affiliate organizations of EANGUS consist of 36 major military and veteran organizations representing 5.5 million members (Military Coalition) and 30 Military and Veterans' organizations (Military AD-HOC).

Why do we need EANGUS? Anti-lobbying act (18 USC 1913) prohibits expenditure of federal funds on "grass roots" lobbying efforts to induce public to contact Congress concerning legislation or appropriations. FISCAL LAW is recurring provision in DOD's annual appropriations act that no funds "shall be used in any way, directly or indirectly, to influence congressional action."

EANGUS is a non-profit organization that is dedicated to promoting the status, welfare and professionalism of Enlisted members of the National Guard by supporting legislation that provides adequate staffing, pay, benefits, entitlements, equipment and installations for the National Guard.

The Legislative Goals of EANGUS are published annually. The goals and objectives were established through the resolution process, with resolutions passed by association delegates at the annual conference. From these resolutions come the issues that EANGUS will pursue in Congress and in the Department of Defense. Resolutions stay in force for two years.

The following persons are eligible:

WNGEA members, unmarried son or daughter's of WNGEA members, Spouse of WNGEA members, and unmarried son, daughter, or spouse of deceased WNGEA members.

Applicants must be enrolled as a full time, part time (minimum credits), graduate or undergraduate student at a college, university, trade or business school. Up to four college grants will be offered in the amount of \$500.00 each for the current school year of application for students taking at least 9 credits. One grant will be reserved for graduate students. In addition, we will have one yearly grant in the amount of \$1,000.00.

That scholarship will be called the "RAYMOND MATERA SCHOLARSHIP" and will be awarded to the individual selected as the top applicant for the year. This award was established by our Executive Council in honor of MG Raymond A. Matera, the former Adjutant General for Wisconsin. Also, a \$1000.00 yearly grant will be awarded from funds donated on behalf of USAA.

Wisconsin National Guard Enlisted Association College Grant Program

The Wisconsin National Guard Enlisted Association has established a grant program. The following persons are eligible: WNGEA members, unmarried son or daughter's of WNGEA members, spouse of WNGEA members, and unmarried son, daughter, or spouse of deceased WNGEA members. Applicants must be enrolled as a full time, part time (minimum 9 credits), graduate or undergraduate student at a college, university, trade or business school.

Up to four college grants will be offered in the amount of \$500.00 each for the current school year of application for students taking at least 9 credits. One grant will be reserved for graduate students. In addition, we will have one yearly grant in the amount of \$1,000.00. That scholarship will be called the "RAYMOND A. MATERA SCHOLARSHIP" and will be awarded to the individual selected as the top applicant for the year. This award was established by our Executive Council in honor of MG Raymond A. Matera, the former Adjutant General for Wisconsin. Also, a \$1000.00 yearly grant will be awarded from funds donated by USAA.

There shall be no consideration whatsoever given because of friendship, rank or grade of applicant, applicant's parents or applicant's spouse. Neither shall the applicant's geographical place of residence in the state be considered. The grants will be awarded on the basis of need, leadership, and good moral character.

APPLICATION PACKETS WILL HAVE THE FOLLOWING ITEMS:

- 1. WNGEA College Grant Program application form.
- 2. Copy of latest school or college transcript. If applicant has been out of school for more than one semester, copy of most recent educational transcript <u>MUST</u> be included.
- 3. A letter from the applicant with outlining facts as to:
 - a. His/her desire to continue their education
 - b. Why financial assistance is needed.
 - c. Awards received, accomplishments, volunteerism and hours volunteered per week or month.
 - d. Organizational membership and role in organization.
- 4. A signed letter of academic reference from Principal, Dean or Counselor.
- 5. Three signed letters of personal reference and recommendation from minister, community leader, etc., giving general personal traits. If applicant is a National Guard member, one of these letters MUST be from their First Sergeant or Commander outlining the soldier's contribution to the unit.
- 6. Proof of acceptance to the applicant's school or educational program.
- 7. Your WNGEA/EANGUS membership will be validated against the current master list from the EANGUS/WNGEA membership database.

A scholarship recipient may not reapply for two years after receipt of a grant. Those persons who applied and were not selected are encouraged to reapply.

If the awardees does not complete the school term for which the grant was awarded due to any cause other than sickness or physical injury, he/she will refund the award to the Wisconsin National Guard Enlisted Association within 60 days of the date enrollment was terminated.

If a new enlistee is unable to complete his/her contract for any cause other than sickness or physical injury he/she will refund the award to WNGEA within 60 days of the date enrollment was terminated.

<u>Applications must be RECEIVED by the Chair no later than 01 June.</u> No other application forms will be accepted other than the current year's application. The deadline for applications will be observed in all instances. In the event of a full Mobilization, the grant program will be suspended and all money placed in a trust fund until such time as the WNGEA shall once again become active.

The college grant/education committee of the WNGEA shall be made up as follows:

- 1. Chairman This person will be appointed by the president of the WNGEA.
- 2. The remainder of the committee shall be made up of A, B or C below.
 - A. Voting members from the Air National Guard and the Army National Guard.
 - B. A committee of professional educators or
 - C. A combination of Air National Guard, Army National Guard members and professional educators.

The president of the WNGEA shall be a permanent associate member of the committee but will have no vote, and will serve in an advisory capacity only.

"The TRICARE Costs and Fees 2022 Fact Sheet is one of the easiest ways to track down your TRICARE coverage costs," said Robert Agnello, deputy chief of the Digital Communications, TRICARE Web and Publications at the Defense Health Agency. "Some rates change in a new calendar year, but some don't, depending on your specific plan. We recommend you check the new rates so you know what to expect before you go get care this year."

Here is a preview of the costs and fees you'll find in this resource:

1. Health Care Costs

Most TRICARE beneficiaries fall into one of two-groups: Group A or Group B. It's important to know what group you're in because each group pays different costs and fees. Whether you have TRICARE Select, or you're enrolled in a premium-based health plan (TRICARE Retired Reserve, TRICARE Young Adult, or Continued Health Care Benefit Program), the costs sheet breaks down costs that may apply to you, like annual enrollment fee, annual deductible, or premium. You can even find what your out-of-pocket costs are for covered services, including:

- Preventive care visit
- · Primary care outpatient visitcare
- Specialty care outpatient visit
- Urgent care center visit
- Emergency room visit
- Inpatient admission (hospitalization)

Do you know what your catastrophic cap is? This is the most you or your family may pay out of pocket for covered TRICARE health care services each year. You can refer to the costs sheet for all this information.

2. Pharmacy Costs

TRICARE groups prescription drugs into <u>four categories</u>: generic, brand-name, non-formulary, and non-covered drugs. And your costs may vary depending on your drug's category. But you don't have to guess what your costs are. The pharmacy cost section lists the costs for each drug category based on which <u>type of pharmacy</u> is used:

- Military pharmacy
- TRICARE Pharmacy Home Delivery
- TRICARE retail network pharmacy
- Non-network pharmacy
- Overseas pharmacy

3. Dental Costs

If you're enrolled in the <u>TRICARE Dental Program</u> (TDP), this fact sheet provides a quick overview of your TDP rates. See the voluntary dental programs section for current <u>TDP</u> <u>monthly premiums</u> based on your sponsor's military status (active duty, Selected Reserve, or Individual Ready Reserve) and type of enrollment (single or family plan). The type of dental service you get and the sponsor's pay grade affect your <u>cost-share</u>. The other table outlines out-of-pocket costs for certain dental services, as well as what the <u>TDP</u> maximums are.
