Housing & Property Tax Relief

Support SB 664 / AB 686 – Expand Wisconsin Veterans & Surviving Spouses Property Tax Credit

- **Lower the Disability Threshold** – Reduce the eligibility requirement from 100% to 70% service-connected disability, allowing more disabled veterans and surviving spouses to qualify for meaningful property tax relief.
- **Proportional Credit for Partial Disability** – Provide a proportional property tax credit for veterans with disability ratings between 70% and 99%, multiplying the credit by the claimant's VA disability percentage to better reflect the severity of service-connected injuries.
- **Maintain Existing Protections** – Preserve current eligibility for veterans rated at 100% service-connected disability and ensure the legislation does **not** alter benefits for veterans rated based on individual unemployability.

Why It Matters - Expanding this credit honors the service and sacrifice of disabled veterans, reduces housing insecurity, and supports long-term stability for military families.

Education Benefits

Support AB 47 / SB 59 – Modernize eligibility for the Wisconsin GI Bill

- **Eliminate the Outdated “Five-Year” Rule** – Remove the legacy requirement that a veteran must have lived in Wisconsin for five consecutive years prior to applying for tuition remission.
- **In-State Tuition for National Guard Members** – Extend in-state tuition to *all* members of the Wisconsin National Guard, regardless of prior residency — like how Wisconsin already supports Active-Duty Service Members.
- **Family Access & Stability** – Preserve tuition remission for veterans, spouses, and children if they are Wisconsin residents at the time of enrollment.

New - SB 640 updates eligibility requirements for the Wisconsin GI Bill by modernizing outdated residency rules that can unintentionally exclude veterans and Guard members due to the mobile nature of military service.

- **Reduces the Residency Requirement** – Shortens the required period of Wisconsin residency prior to eligibility (from five years to three years).
- **Maintains Wisconsin Residency Tie** – Requires the veteran or dependent to be a Wisconsin resident at the time benefits are used.
- **Incremental Reform Approach** – Improves access while maintaining existing program structure and fiscal controls.
- **Focus on Veterans & Dependents** – Applies primarily to veterans, spouses, and children, without fully addressing Guard member in-state tuition parity.

⌚ **SB 640** improves the Wisconsin GI Bill by **shortening** the residency requirement but **keeps residency-based barriers in place**.

⌚ **AB 47 / SB 59** fully modernize the program by **removing outdated residency rules**, extending **in-state tuition to all Wisconsin National Guard members**, and aligning Wisconsin with the realities of military service.

Why It Matters - Removing housing-based barriers to education honors service, unlocks workforce potential, and ensures Wisconsin remains a top destination for military families to *live, learn, and stay*.

💰 Tax Fairness for Service Members

Support Legislation to Exempt Annual Training & Drill Pay from Wisconsin Income Tax

- **Eliminate the Current Gap** – Wisconsin exempts full-time Active-Duty pay yet still taxes the required **Annual Training (AT)** and monthly **Inactive Duty Training (IDT) drill weekends** that Guard members must perform to remain ready for state and federal missions.
- **Follow a Proven Model** – Update **Wis. Stat. §71.05(6)(b)34** (or similar statute) to **include AT and IDT pay** as exempt income.
- **Recruitment & Retention Advantage** – Wisconsin competes nationally for talent. Half of Guard units report personnel shortages. This policy would offer a retention tool that keeps trained Soldiers and Airmen in uniform.
- **Fairness for the Dual-Mission Force** – The National Guard is the only force activated by the Governor to respond to natural disasters, civil unrest, cyber emergencies, and statewide crisis support — those who serve our communities should not pay more for the privilege of doing so.
- **Meaningful Financial Relief** – Guard members rely on drill pay to support their families. Reducing tax burden puts money back into local economies and helps service members stay in Wisconsin.

Why It Matters

This change **rewards continued service** and strengthens readiness — ensuring Wisconsin has the trained forces needed during fires, floods, blizzards, or mobilizations abroad. Guard members should not be taxed differently for the same uniform they wear to defend Wisconsin and our nation.

🏆 Defining “Veteran” Consistently

Support Alignment of Wisconsin Statute § 45.01(12) with the Federal Definition

- **Close the Current Gap** – Wisconsin’s definition of “veteran” is narrower and inconsistent with the federal standard used by the Department of Veterans Affairs (VA). This creates confusion, duplicate eligibility checks, and unintended denial of benefits to those who have served honorably.
- **Federal Standard is Clear and Inclusive** – A veteran is anyone who served in the active military, naval, army, air, or space service and was discharged under conditions other than dishonorable, including:
 - Active duty
 - Active duty for training where the member was disabled or died in the line of duty
 - Inactive duty for training where the member was disabled or died in the line of duty
 - Service where a discharge status was later upgraded or reviewed under the VA’s established process
- **Wisconsin Currently Adds Extra Barriers** – In some programs, eligibility is tied to length of service, specific campaign badges, discharge dates, or residency requirements — none of which appear in the federal baseline definition.
- **Administrative Efficiency** – Aligning with the federal definition would allow Wisconsin agencies to simply accept VA determinations, reducing paperwork, appeals, and delays for veterans and surviving families.

New: SB 387 / AB 389 – Expand Definition of Veteran

Summary: Expands the statutory definition of “veteran” to allow more individuals to indicate veteran status on Wisconsin driver licenses and state IDs, improving access to veteran identification and benefits.


